Investment Strategies

The Small Cap Portfolio normally seeks to achieve its objective by investing at least 80% of its net assets in securities of companies with market capitalizations which, at the time of initial purchase, fall within the range of companies in the Russell 2000 Index at reconstitution each June. The adviser believes that there are greater pricing inefficiencies for small cap companies than larger capitalization securities.

The adviser uses a company specific approach to making investment decisions, which focuses on identifying stocks of growth companies that are selling at a discount to the companies' projected earnings growth rates.

The adviser looks for companies where fundamental changes are occurring that could lead to increases in revenue growth rates, expanding profit margins, and/or increases in earnings growth rates. The adviser typically invests in a company only when the adviser believes that such changes will lead to greater investor recognition and higher stock prices within a 12- to 24-month period.

Investment Objective

The Small Cap Portfolio seeks maximum capital appreciation, consistent with reasonable risk to principal, by investing primarily in small market capitalization companies.

- The stock reaches the target price set by the adviser
- The stock falls below the downside price limit set by the adviser
- The fundamentals of the stock have deteriorated
- A more attractively valued alternative is available for purchase

It encapsulates the amount of earnings estimated for next year per dollar of current share price. For the fund, the individual P/E stock ratios are then weighted by their respective portfolio market values in order to calculate a weighted average representative of the portfolio as a whole.
